WELCOME: The Hon. F.J. Kitts Esq. H.P. Mayor of Wellington briefly addressed a message of welcome to delegates and others from the briefly addressed a message of welcome to delegates and others from Citizens of Wellington. He expressed great interest in honey both as a food and as a base for alcoholic drinks and wished Conference success in it's deliberations.

Conference was declared officially open by the Hon. Minister of Agriculture Mr. C.F. Skinner. In doing so he expressed regret that he was not as yet able to give definite advice of Government's proposals for assistance to the Industry along the lines which had been requested by the Executive and Honey Marketing Authority. He expected to be in a position to make an announcement at an early date

At the end of his address the Minister answered questions as follows :-

<u>Petrol Tax</u>: He did not consider that Government would grant refrom Petrol Tax to the Industry and further that the provision for relief which had been granted to farmers would be of little or no He did not consider that Government would grant relief assistance to beekeepers as it applied only to Tractors, Pumps and Stationery Equipment used on the farm and not to the use of farmers' vehicles on highways.

Guaranteed Price:

A guaranteed price was not a government subsidy. was operated solely out of producers funds from the sale of their produce overseas. The Government advanced to the Pool in times of low overseas returns but expected these advances to be repaid from the Pool during a period of higher returns.

The President in thanking the Minister for his address, expressed the hope that Government would have better news for the Industry at an early date when it advised it's decision on the Industry's

MESSAGES OF GREETINGS.

HONEY MARKETING AUTHORITY REPORT.

The President welcomed E.A. Field Esq. Chairman of the N.Z. Honey Marketing Authority and invited him to report on the operations of the Honey Marketing Authority during the past year. observations of the money personner authority during the property field's written report will appear in the angust issue of the N.Z. Beckeeper.) At the conclusion of his address Mr. Field enswered questions as follows:

Is the authority elleging that the Association or it's Officers have acted in any way prejudicial to the Authority's operations. un Suallie Als.

The Statement in the Report merely gives the respective of functions of the two organisations as the Authority sees them. What is the cost of the new building in Auckland and stion :what portion is being met by the Government. The final cost is not yet known but will be under £100,000. Finance is by means of a 100% State What cost was saved by not replacing the two members of the office staff which left the Authority's employ and why was this saving not effected before by dismissing them as redundant. The Net Saving is approximately £700 per annum after allowing for increases in salary of other personnel. The greater staff was required in the early stages owing to a greater volume of honey being handled. What substantiation is there for the allegation that private packers are cutting prices on Auckland Markets. The Authority's Agent has assured the Authority of this position from his personal knowledge. In view of the low returns from the Authority's local Market Sales in comparison to it's high cost of Question :maintaining this market, would not the Authority consider it more prudent to devote it's energies entire-ly to the export market and so receive increased income from seals revenue from the operations of producerpackers on local market. The Authority does not consider this to be good policy for it would be losing it's first line of defence in the event of a drop in overseas returns. What advertising is being undertaken by the Authority. Question :-Answer :-£1,000 was spent on advertising honey generally in New Zealand last year. This year £500 is being spent on advertising the Honey Marketing Authority's own packs. An address on the activities of the Apiary Section, Department of Agriculture was given by Mr. A.M.W. Greig, Director of Horticulture. (A full report of Mr. Greig's address will appear in the August issue of the New Zealand Beekeeper.)

N.B.A. ANNUAL REPORT AND ACCOUNTS.

A report on the sctivities of the Association during the past year and statement of accounts for the year ending 31st. May, 1958 were presented by the President, Mr. J.W. Fraser who formally moved their adoption. (Copy of the President's Annual Report will appear in the August issue of the N.Z. Beakeeper.) In discussion of the Annual Accounts it was noted that the General Account had closed with a deficit of £179 at the end of the financial year. Some criticism was directed at the Executive for the high level of expenditure during the past year but it was pointed out that expenditure was more or less in direct proportion to the number of important matters which had been dealt with during the year and this view was strongly supported from the floor.

MOTION.

Mr. J. Glynn gave notice of his intention to move on and day of Conference that the full allocation of £1,000 able to the Association from the Seals Fool Provision Account be aby the Executive each year until approximately £1,000 credit ated in the General Account to cover the cost of any exceptional presse in the Associations programme of work which may arise.

The attention of conference was then directed to the consideration of remits before which the following procedural motions were put and carried :-

- That the late Remits from South Auckland Branch be accepted for inclusion in the Agenda.
- That new members at present financial but not financial at the close of the financial year ending 31st. May be accorded speaking rights.
- That speaking times be limited to 3 minutes for the mover of a motion and 2 minutes for other speakers and 2 minutes for mover exercising his right of reply.

LIFE MEMBERSHIP - MR. T.S. WINTER.

The President advised Conference that the Executive had been pleased to unanimously endorse the request of Otago and Southland Branches that Mr. T.S. Winter be made a Life Member of the Association. The bestowing of this honour was commended to conference accordingly. Numerous speakers from the floor referred eulogistically to the long term of service which Mr. Winter had given to the Industry and to the remarkable manner in which he had assisted personally many individual beekeepers. The motion was put and carried unanimously amidst acclamation and Mr. Winter, accompanied by his wife were invited to the rostrum by the President where Mr. Winter suitably replied to Conference. The President then presented Mr. and Mrs. Winter with a token of esteem from the Beekeepers of New Zealand.

REMIT NO. 1.

"That this Conference supports the principle of Government Assistance for the Beekeeping Industry by means of a guaranteed return to Honey Marketing Authority suppliers equal to the cost-of-production as established by costs survey." (Moved by Mr. J. (Moved by Mr. J. Glynn seconded Mr. R. Hillary.)

With the consent of Conference the following words were added "And in the event of this being unsuccessful some other form of Government Assistance." Mr. Bray opposed the Remit asserting that the Guaranteed Price Principle had been proved unsound and urging the Industry to press for capital relief for the Honey Marketing Authority. Other speakers supported the view that after the Minister's statement it was pointless to pursue the Guaranteed Price.

"That in view of the statement from the Minister ADENDMENT. (Moved by Mr. W. Nelson seconded Mr. Baker.) The amendment was put to Conference by delegates vote and CARRIED and also declared CARRIED AS THE MOTION.

REMIT NO. 2.

"That in the event of remits being passed at Conference the President give an explanation in his annual report at the following Conference if no action has been taken." (Moved Mr. Nelson, seconded Mr. Bray.) The motion was put and declared CARRIED.

REMIT NO. 3.

ae for next year's Conference were strongly advocated by Mr. delegate for the Nelson Branch.

NO. 3A.

"That 1959 Conference be held in Timaru." (Moved by the Centenary of the South Centerbury district and that it was 21 years since a Conference had been held in Timaru. Mr. R. Hillery advocated that 1959 Conference be held in Auckland as it would give members an opportunity of viewing the completed Honey Marketing Authority building. However, after discussion the Remit was FUT and declared CARRIBD.

REMIT NO. 3B.

"That in view of the difficulty of securing accommodation for Conference during mid-week periods, consideration be given to holding future Conferences over a week-end period." (Moved by Mr. Fraser, seconded Mr. Gumbrell.) This remit was considered by discussion groups and analysis of group findings disclosed that the points in favour of holding a Conference over a week-end period were far outweighed by those against such a practice. The motion was put to Conference in Flenary session and declared LOST.

REMIT NO. 5.

"That the nomination and election of candidates for the Honey Marketing Authority be on a ward system." (Moved Mr. Gumbrell seconded Mr. Closke.) In introducing the remit Mr. Gumbrell advised that, if passed, it could not come into effect for the next election. He considered that the diversity of types of honey produced in different parts of New Zealand and the problems associated with each type of honey and type of production made a ward system necessary. He contended that only where Authority Members had a knowledge of the production problems of the beekeepers they represented could the administration of the Authority be sound and reflect to the benefit of the whole industry. Under the present system it was possible for the Authority to be comprised solely of members from one small area with no knowledge of the problems of other areas and this could not be guarded against without the introduction of a ward system of representation. Mr. Nelson opposed the remit and maintained that under the present system the best brains in the industry could be elected to the Honey Marketing Authority. At the present time members of the Authority worked in the interest of the industry as a whole whereas under a ward system members would be more inclined to work for the interests of their ward as opposed to the interests of the industry as a whole.

The remit was then considered by 8 independant discussion groups and the analysis of group findings indicated that most members considered that the advantages of a ward system would be outweighed by the disadvantage of parochial influence. The motion was put to Conference in plenary session and declared LOST.

ADDRESS ON AGRICULTURAL CHEMICALS.

At this junction Conference adjourned to hear an illustrated address by Mr. T. Palmer-Jones, Principle Research Officer, Department of Agriculture, on "Agriculturel Chemicals and the Beekeeping Industry." Mr. Palmer-Jones detailed experiments which had been carried out in determining the toxicity of various chemical substances to bees and in evolving systems for the application of pesticides to crops without danger to honey bees. At the end of his address Mr. Palmer-Jones answered numerous questions and was thanked by Conference on his most interesting address.

REMIT NO. 5A.

"That in the event of the Executive making an official representation on revised voting qualifications to the Honey Marketing Authority the Executive first obtain the views of suppliers to the Authority." This remit was WITHDRAWN by Mr. M. Nelson seting as delegate for the sponsoring branch in favour of Remit No. 30.

"That the method of voting by suppliers' to packers by Marketing Authority elections be simplified; the returning for to send all commercial beekeepers an appropriate form to sential the amount of honey supplied to packers and allot votes condingly." This remit was withdrawn following an explanation that he returning officer was bound by the provisions of the Electoral and polls Act.

REMIT NO. 6A.

"That in view of the fact that many Apiarists live a considerable distance from a Justice of the Peace, declarations of honey supplied to a producer-packer be witnessed by a Postmaster, Clergyman, Solicitor etc." This remit was also WITHDRAWN following an explenation that the taking of declarations of this nature was covered under the Statutory Declarations Act and could not be varied without invalidating the election.

REMIT NO. 7.

"That Manuka Honey should get equal subsidy from the Seals Fund as other honey." Mr. Field advised that Manuka participated in the pool through bonus payments at the present time and therefore did receive equal subsidy from the Seals Fund as other honeys. Accordingly the remit was WITHDRAWN.

REMIT NO. 8.

"That Conference request the incoming Executive to press for better terms of interest for the Honey Marketing Authority building. Conference has twice requested this but no result has been achieved by the Executive." (Moved Mr. Pearson, seconded Mr. Bray.) Mr. Chandler, rising to a point of order, explained that the Honey Marketing Authority and National Beekeepers Association Executive had agreed following last Conference upon a co-ordinated plan in pursuit of government assistance. The Executive had amply fulfilled it's undertaking under this agreement and he asked the Honey Marketing Authority to account for it's actions on the matter. He made this statement to refute charges that the Executive had been guilty of neglect. Mr. Closke supported Mr. Chandler's contention.

By agreement the words "Incoming Executive" were deleted and the words "Honey Marketing Authority" were substituted and the motion was put and CARRIED.

REMIT NO. 9.

"That Conference views with concern the fact that the Honey Marketing Authority has neglected to carry out the resolution passed at the last Conference to press local sales." (Moved Mr. Gregory, seconded Mr. Jay.) In answer to the inference of "neglect" Mr. J.W. Fraser said that the present Authority was unanimous that local sales should be increased and detailed the steps which had been taken, viz. A New Agent; Raising the quality of the pack; Appointment of Mr. Nelson to supervise packing operations, and consideration of advertising methods. After brief discussion the remit was put and LOST.

REMIT NO. 10.

"That the Honey Marketing Authority take immediate steps to place another pack on the local market at a price and of a grade to meet the competitive selling of possible price cutting."

(Moved by Mr. Nelson, seconded Mr. Herron.) Mr. Cloake opposed the remit due to the fact that the Honey Marketing Authority could not control the price to the consumer. By supplying honey to Merchants and Retailers at a reduced price they were virtually conniving in price cutting and giving the middle—man an additional profit to which he was not entitled. Mr. Haines supported the principle of a second pack but did not support the principle of a reduced price. Mr. Field in answer to a question advised that the Agent considered that there was a place for a second pack at a reduced price. He added however that the wisdom of taking such action depended upon the types of honeys and supplies generally to the Honey Marketing Authority and the level of prices overseas. Mr. Benny contended that the Authority could not

Mr. Chandler contended that the Authority should sell on the same terms as private packers, that is, at a discount. He contended that this was not price cutting.

The motion was put and declared LOST.

REMIT NO. 11.

"That the Association adheres to the principle of a floor price for honey." With the permission of Conference this remit was brought forward in amended form as follows: - "That the Executive explore the advantages or otherwise of a floor price for honey and take action accordingly." After brief discussion the remit was put and CARRIED.

REMIT NO. 12.

"That the Executive take action to have the profit margin controlled on all retail packed honey handled by the Wholesale and Retail Trade." (Moved Mr. Nelson, seconded Mr. Gumbrell.)

Mr. Pearson said that beekeepers require the goodwill of the trade and as they reserved for themselves the right to fix margins the remit was an impossible request.

Mr. Bray
In supporting Mr. Pearson urged the necessity for giving the trade every incentive to promote sales.

 $\underline{\text{Mr. Field}}$ emphasized the importance of retaining the goodwill of merchants and grocers.

The remit was put and LOST.

REMIT NO. 13.

"That an up-to-date cost-of-production factor be undertaken by the Department of Agriculture." It was resolved that Conference go into Committee to discuss this remit. In committee it was decided that the remit be considered in amended form viz: "That the cost-of-production survey be brought up to date." (Moved Mr. Hill, seconded Mr. Ashcroft.) The remit as amended was put and CARRIED.

REMIT NO. 14.

"That all pesticides be clearly labelled by manufacturers as being toxic or not toxic to honey bees and that an exact time for applying same be stated." (Moved Mr. Gregory, seconded Mr. Cloake.)

The President explained that the Executive had already pressed the matter with the Government and that provision for labelling of pesticides was already included in the draft provisions of the Agricultural Chemicals Bill.

Mr. Greig

confirmed that this was correct.

The motion was put and CARRIED.

REMIT NO. 15.

"That investigation be made to ascertain the extent to which hormones are harmful to bees." (Moved Mr. Gumbrell, seconded Mr. Glasson.)

mentioned that mysterious losses of bees continued to thoughout the country and there appeared to be some evidence to the claim that hormone week killers were responsible.

The remit was put and CARRIED.

EMIT NO. 16.

With the permission of Conference this remit was presented in amended form as follows:-

"That in view of the weakness in the Regulations which permit Toxic Pesticides to be applied to flowering pastures and crops other than legumes and brasicess, this conference request that the present Regulations be extended to cover all other possible exigincies." (Moved Mr. Gumbrell, seconded Mr. Gloske.)

Mr. Greig in explanation advised that this matter was covered under the provisions of the draft Agricultural Chemicals Bill. After trief discussion the motion was put and CARRED.

REMIT NO. 17.

"That the Executive approach the Department of Agriculture with the view to having the allocation of part time inspection increased to meet extra costs and maintain this valuable service to the Honey Industry,"

This motion was WITHDRAWN.

REMIT NO. 18.

"That Conference again request the Department of Agriculture to take the earliest opportunity of sending an officer to the U.S.A. to study at first hand, methods of Apiary Management." (Moved by Mr. N. Glass, pro-forma.)

Mr. Greig in explanation of Government and Departmental policy pointed out that Government grants for Departmental visits overseas was now strictly limited and that unless the industry had some specific matter of major importance which it wished to have investigated there was no possible chance of an officer being sent overseas again in the forseeable future.

The motion was put and LOST.

REMIT NO. 19.

"That Conference request the Department of Agriculture to conduct experiments in pollination with the aim of determining statistically the value of bees and other pollinating insects." (Moved by Mr. N. Gless, seconded Mr. R. Hillery.)

The Chairman called on Mr. T. Palmer-Jones to explain the present plan and scope of work being carried out in Pollination Research.

After Mr. Palmer-Jones had given his explanation of the present work being undertaken the motion was put and CARRIED.

REMIT NO. 19A.

"That an Apiculturist be appointed forthwith to the South Island." (Moved Mr. H. Closke, seconded Mr. Gumbrell.)
The proposers mentioned the valuable work at present being done by Mr. C.R. Paterson in the North Island and expressed the view that much important work in the South Island especially in connection with pollination and field research merited the appointment of a similar senior officer in the South Island.

Mr. Greig queried the Association's right to seek the creation of a particular official status. The Industry, he maintained, could ask for a particular job of work to be done but it was then over to the Department to decide what personnel should be engaged on the work.

strongly disagreed with this view maintaining that it is interests of the industry that officers engaged on ist work receive specialist designations.

The metion was put and CARRIED.

MIT NO. 20.

"That the Department of Agriculture be asked to initiate a programme of original research into bee diseases." (Moved Mr. Clynn, seconded Mr. Herron.) Both speakers considered that inatead of relying on work being dome overseas the department should investigate diseases of a minor nature which could never-the-less substantially reduce hive numbers and affect the strength of the hive at vital times of the vear.

After brief discussion the motion was put and CARRIED.

REMIT NO. 21.

"That the Apiery Section of the Department of Agriculture be requested to conduct experiments in order to evolve an efficient commercial system to produce the maximum quantity of beeswax from a hive of bees and to estimate the probable cost-of-production thereof." (Moved Mr. Gumbrell, seconded Mr. Cloake.) In introducing the remit Mr. Gumbrell stated his conviction that there were sound commercial possibilities for beekeepers in dark-honey producing areas to turn their production entirely to wax to the disregard to honey production.

Mr. McFadzien opposed the remit considering that beekeepers themselves were in a better position to experiment with wax production in view of their better knowledge of local conditions such as Nectar and Pollen sources and local weather conditions.

After brief discussion the motion was put and LOST.

PRACTICAL ADDRESS.

At this juncture Conference adjourned for an address by Mr. C.R. Peterson, Apiculturist, Department of Agriculture, on "A New Type Honey-Creamer" and "An Advanced Honey Strainer." Mr. Faterson had models of both sets of equipment on view and delivered a most informative talk on the operational principles of both machines. Conference showed it's sincere appreciation of the address in the customary manner.

REMIT NO. 22.

"That in view of current restrictions on importation of spirits the Executive investigate the possibility of manufacturing Gin from distilled mead and for making of mead on a commercial scale." (Moved Mr. E.D. Williams. seconded Mr. Gumbrell.)

Mr. Williams in introducing the remit with the permission of the Southland delegate gave a background picture of steps already taken by the Executive of the Association in pursuing this matter and in which he (Mr. Williams) had figured at the request of the Executive.

A number of speakers referred to the large financial gains which could accrue to the industry through the use of honey for alcoholic beverages.

Strong opposition was recorded against the proposal by Messrs. W. Bray, Palmer, Marshall, A. Pearson and Asheroft on ethical and religous grounds. Subsequent speakers applauded these members for their stand on what they considered to be a matter of principle but pointed out that alcoholic beverages would continue to be made and consumed in any case through the dictates of popular public demands.

On being put the motion was declared CARRIED.

"That in view of the falling overseas market for honey conference approach the Government concerning the manufacture of As this matter had already been dealt with under the reding remit it was WITHDRAWN.

EMIT NO. 23.

"That Conference opposes any increase in Petrol Tax."

By agreement the word "the" was substituted for the word "any".

Mr. Closke, seconded Mr. McFadzien.) Some speakers thought there was

"That the National Executive take immediate action to beekeepers 30 days notice of each works contemplated within a quarter of a mile of an apiory." On being put the motion was declared CARRIED.

"That the Executive investigates the possibility of securing fresh films of interest to the beekeeping industry from overseas. (Moved Mr. McFadzien, seconded Mr. Hewlett.)

drew attention to the large number of technical films on beekeeping subjects which had been produced overseas and advised that at the forthcoming world conference of beekeepers to be held in Rome the official programme showed that a number of such films would be shown.

Mr. Newlett considered that the matter may be taken a stage further with the production of some films on beekeeping matters in New Zealand.

No contrary opinions were expressed and the motion was put to Conference and declared CARRIED.

"That immediate action be taken to enlist the aid of the State Forest service, Catchment Boards, County Councils and other like bodies to further the planting of trees that are nectar secreting as well as being useful for timber." (Moved Mr. Gumbrell, seconded Mr. Pearson.)

Gumbrell drew attention to the fact that a number of farm Forestry Associations were being formed in different parts of the country under the sponsorship of the Conservator of State Forests and instanced an Association which had recently been formed in South Canterbury. Through the efforts of beekeepers in that area it had been possible to arrange an official invitation to the initial meeting of a senior member of the Apiaries Staff, Department of Agriculture who had been able to advise on various species of trees and shrubs which were both useful from a fermers point of view and from the beekeepers point of view as nectar and pollen secreting.

The motion was put and CARRIED.

"That it be a recommendation to the Honey Marketing Authority that the Analysis issued by the Manager on it's operations since it's inception be published in the journal." (Moved Mr. R. Hillary,

opposed the remit on the grounds that some of the remation was confidential to the industry whereas the journal sulation was by no means confined to beekeepers.

The motion was put and CARRIED in this form.

"That a report on the suitability of the new Honey Marketing Authority premises with particular reference to it's loading and unloading facilities and it's floor loading capacity be given to

The Chairman stated that he understood Mr. W. Nelson, member of the Honey Marketing Authority had investigated the very complaints raised in the remit, and he invited Mr. Nelson to report on these matters.

After Mr. Nelson had given his report covering the complaints raised in the remit, the remit was WITHDRAWN.

REMIT NO. 29.

"That the Department of Agriculture be urged to investigate immediately the value of bees in regard to pollination and it's ultimate effect in the economy of the country."

This remit was $\frac{\text{WITHDRAWN}}{49}$ as the matter had previously under remit No. $\frac{1}{49}$. been dealt with under remit No.

REMIT NO. 30.

"That the whole question of voting qualifications for the Honey Marketing Authority be investigated."

Mr. J.W. Fraser requested that the remit be withdrawn as the request was not specific enough to enable the Executive to give the matter action.

Accordingly the remit was WITHDRAWN.

"That Conference requests the combined efforts of the Honey Marketing Authority and the National Beekeepers' Association to be continued in an endeavour to secure a guaranteed price based on the cost-of-production and in the event of this being unsuccessful some other form of government assistance.

The subject matter of this remit having been dealt with in previous discussion on another remit the remit was WITHDRAWN.

REMIT NO. 32.

"That the Honey Marketing Authority endeavour to reduce the volume of honey requiring reconditioning for export and that such honey be sold on the local market before the honey deteriorates. (Moved Mr. J.I. Jay, seconded Mr. Pearson.)

Messrs. Field and Bray pointed out that steps had already been taken by the Authority along the lines suggested in the light of the Authority's experience. On being put the motion was declared CARRISD.

REMIT NO. 33.

"That the Honey Marketing Authority be requested to publish in each issue of the journal reports of overseas prices from varied grades of honey." (Moved Mr. R. Hillary, seconded Mr. Bird.) Conference consideration of this remit was held in Finally the words "by way of insert" were inserted after the reports" and the motion put and CARRIED.

MIT NO. 34.

"That Conference deplores the dilatory actions of the Money Marketing Authority in selling honey on the local market and again request action and results in this direction." This remit was WITHDRAWN as it had already been dealt with under previous discussion.

DEMTT NO. 35.

Authority that payout points be settled at the time of grading as in the past and that no penalty be applied for subsequent reconditioning."
(Moved Mr. R. Hillary, seconded Mr. Lorimer.) The proposers cited cases of suppliers having their initial grading points lowered up to 8 months after supply and considered this to be grossly unfoir to the supplier. The supplier had no guarantee that this honey was being stored in the best of conditions and regrading of honey after the Authority had held it for lengthy periods was an unfair imposition on the producer.

Mr. Field stated that in some cases it was impossible to detect defects in the honey at the time of supply such as when slightly fermented starter had been used by the producer in granulating his honey prior to shipping.

After further debate the motion was put and CARRIED.

REMIT NO. 36.

"That the Honey Marketing Authority be urged to abandon any attempt to put a second pack over a 75 grading on the local market at reduced price." As this matter had been dealt with in discussion of a previous remit, the remit was WITHDRAWN.

ELECTION OF OFFICERS.

The election of officers conducted on the third day of Conference resulted as follows :-
