MINUTES OF THE ANNUAL GENERAL MEETING OF THE NATIONAL BEEKEEPERS ASSOCIATION OF NEW ZEALAND (INC) AND THE CONFERENCE OF BRANCH DELEGATES HELD IN THE CONFERENCE ROOM, EDGEWATER HOTEL, RAROTONGA, COOK ISLANDS ON MONDAY, TUESDAY AND WEDNESDAY, 9,10 AND 11 JULY 1990 COMMENCING AT 9.52 A.M. ON MONDAY 9 JULY 1990

WELCOME TO DELEGATES:

The President welcomed all delegates to this the first NBA AGM and Conference to be held outside New Zealand. He hoped that the surroundings would be conducive to a constructive relaxed but productive and forward thinking meeting.

PRAYER:

Bishop Leamy of Rarotonga then spoke to the delegates and blessed the conference and the deliberations of the members.

Dr Koekoe Mokotupu then read the conference prayer in the language of the hosts and Mr John Heineman then read the prayer in English.

WELCOME:

The delegates were welcomed to the Cook Islands by the Minister of Agriculture the Hon. Vaine Tairea M.P.

PRESENTATION:

In presenting a nectar bearing tree to the Minister the President advised that it was the custom to make similar presentations at other centres where conference had been held, in the hope that the community would appreciate the importance of nectar and pollen bearing trees to the beekeeping industry.

Mr Gavin White, Vice President on behalf of the meeting recorded a vote of thanks to the Minister and Bishop Leamy.

The Minutes of the Annual General Meeting and of the Conference of Delegates held on Tuesday and Wednesday 26 and 27 July 1989 having been circulated, were taken as read, and the Chairman authorised to sign them as a true and correct record.

ADJOURNMENT:

The Annual General Meeting of the National Beekeepers' Association of New Zealand (Inc) was adjourned at 9.53 a.m. for morning tea to allow for the Conference of Branch Delegates which commenced at 10.37 a.m.

(Executive Secretary's note: The Annual General Meeting re-convened at 3.29 p.m. on Wednesday 11 July 1990 following the conclusion of the conference of Branch delegates.)

REMITS:

1. WAIKATO

IT IS THE RECOMMENDATION OF THE CONFERENCE THAT EXECUTIVE SHOULD ACT MORE FULLY ON REMITS PASSED AT CONFERENCE AND THAT REPORTS BE GIVEN BACK TO THE BEEKEEPERS

FOOTNOTE: It is felt that Executive's activities are being guided less by the domestic expression of beekeepers' view through remits to Conference, than it should be. Regular

concise progress reports should be made throughout the year in Buzzwords, on the progress on remits passed at Conference.

Amendment: that the words "more fully" be deleted.

The amendment was LOST 3-9

Amendment: to delete the words "and" and add the words "to the effect" and "more" so that the remit would read "..... conference to the effect that more reports be given back to the Beekeepers".

The amendment was CARRIED 11-1

The amended motion was carried 12-0

2. BAY OF PLENTY

THAT THE CONFERENCE RECOMMENDS TO EXECUTIVE THAT THE NUMBER OF HIVES OWNED BY BEEKEEPERS FOR HIVE LEVY PURPOSES BE LOWERED FROM 50

FOOTNOTE: That this may increase paying membership

The meeting agreed by 10 votes to 4 that this motion should lie upon the table.

3. BAY OF PLENTY

THAT THIS CONFERENCE RECOMMENDS TO EXECUTIVE THAT ANY CHANGES SOUGHT TO SECURE FUNDING FOR THE DISEASE INSPECTION AND CONTROL PROGRAMMES RECOGNISE THAT ALL BEEKEEPERS BENEFIT FROM THE SERVICE AND SHOULD CONTRIBUTE TO ITS PROVISION

FOOTNOTE: We feel that the current Hive Levy lower point of 50 hives is not a good indicator of the beneficiaries of a disease inspection service. With any

changes to come with the Commodities Levy Bill,
National Executive should continue to attempt to broaden the funding base in so far as possible.
This will accurately reflect the fact that all beekeepers require and benefit from the services whether hobbyist or commercial.

This motion was CARRIED 13-1

4. MR R. BERRY

THAT THIS CONFERENCE RECOMMENDS THAT THE NBA EXECUTIVE REASSESS THE NEED FOR EXTRA LEVIES FOR FUNDING THE APIARY REGISTER AND DISEASE INFORMATION SERVICES

FOOTNOTE: Many remits with different approaches to the problem and different answers have been passed over the past 4 years. It is now time for our Executive to rethink the problem in Light of the current beekeeping industry situation and not be over influenced by the thinking of 4 years ago.

5. AUCKLAND

THAT THIS CONFERENCE RECOMMENDS TO THE EXECUTIVE THAT:

THE PRIORITIES OF THE BEEKEEPING INDUSTRY ARE:-

- 1. THAT BEEKEEPING REMAINS A PROFITABLE INDUSTRY
- 2. THAT THE NATIONAL BEEKEEPING ASSOCIATION REMAIN A DOMINANT FORCE WITHIN THE INDUSTRY

3. THAT THE MINISTRY OF AGRICULTURE AND FISHERIES IS RETAINED AS AN ADVISORY SERVICE ONLY

FOOTNOTE: This branch is concerned at the increasing influence MAF is having within the industry.

The meeting agreed by 13-1 that the mover of the Remit be allowed to make the following amendment to para 3 - so that it read:

"That the Ministry of Agriculture and Fisheries is retained as an advisory and regulatory service".

Amendment that the second, third, fourth and fifth lines be deleted and the word "only" be reinstated at the end.

The amendment was CARRIED 7-2.

A notice of further amendment was not proceeded with.

The amended motion was LOST 0-14.

6. WAIKATO

THAT THIS CONFERENCE RECOMMENDS TO EXECUTIVE THAT MAF'S INFLUENCE ON THE NBA AFFAIRS BE REDUCED

FOOTNOTE: It has been felt for some years that a lot of the NBA Executive's time (money) has been spent on trying to arrange funding for MAF, when more of the NBA's time would have been better spent on trying to improve beekeeping profitability.

It is noted that MAF had an unnecessarily high input into the last Beekeeping Industry Planning meeting, at which all New Zealand's Apicultural Advisory Officers were present.

The motion was LOST 5-8 and upon a poll being called for was LOST 408-562.

7. CANTERBURY

THAT THIS CONFERENCE RECOMMENDS TO THE EXECUTIVE THAT IN THE LIGHT OF A VERY SERIOUS AND EXTRANEOUS OUTBREAK OF AMERICAN BROOD DISEASE IN THE CANTERBURY AREA THAT AN APIARY ADVISORY OFFICER BE APPOINTED FORTHWITH

The meeting agreed by 13-0 that this remit could be withdrawn

ADJOURNMENT:

The meeting adjourned at 12.12 p.m. for lunch and reconvened at 2.32 p.m.

- Attempts to prevent Germination of Nosema apis spores
- Effect of Sugar Syrup additives on Mosema in caged bees

7. <u>C.S.I.R.O.</u> Disease & Disorders of Queen Honey Bees

Ms Helen Giacon read to the meeting a report from Dr Denis Anderson (Appendix III).

REMITS:

8. SOUTH WESTERN DISTRICTS

THAT THIS CONFERENCE RECOMMENDS THAT ALL HIVE LEVY PAYERS BE TOLD JUST HOW THEY CAN CONTINUE TO PRODUCE HONEY AT LESS THAN THE COST OF PRODUCTION, IN DOING SO, PLEASE REMEMBER, THAT ON AVERAGE, ONE YEAR IN FIVE CAN BE A CROP FAILURE

FOOTNOTE: No successful business, large or small, can afford not, to sit down and work out the profitability or not, of that particular industry, and if working at a loss not do something about it. This Remit is not an attempt to gang up on the consumer but rather to ensure the continuing survival of many, long established beekeepers.

The motion was LOST 1-11

9. WAIKATO

THAT THIS CONFERENCE RECOMMENDS TO EXECUTIVE THAT A LOT MORE EMPHASIS BE PLACED ON INVESTIGATING AND ENCOURAGING THE IMMEDIATE REDUCTION OF THE COST OF PRODUCING A TONNE ON HONEY AS WELL AS OTHER BEEKEEPING PRODUCTS AND SERVICES

FOOTNOTE: In New Zealand for some time the cost of producing a tonne of mixed source honey has been higher than the world market honey price. This puts us in a very vulnerable position.

We either have to get the world Honey prices up or New Zealand's honey production cost down. If the N.Z. honey market is maintained at above world honey prices, as it has been for some time, this will encourage importation of overseas honey!

10. N.Z. HONEY PACKERS ASSOCIATION

THIS CONFERENCE RECOMMENDS THAT THE NBA EXECUTIVE SHOULD ESTABLISH AN ASSOCIATION OF HONEY EXPORTERS FOR THE PURPOSES OF PROMOTING, CO-ORDINATING AND SUPPORTING THE ACTIVITIES OF RECOGNISED EXPORTERS OF HONEY PRODUCTS FROM NEW ZEALAND

FOOTNOTE: With increased hive numbers in New Zealand over recent years, and the likelihood of annual production of honey consistently exceeding domestic consumption as a result, then greater emphasis must be given to exporting of honey each year to gain stability for both export and domestic prices.

> Exporting is a specialised field in which there is considerable potential for mistakes and problems. Importing countries are increasing their demands for export standards and competition in many of our markets is considerable. Speciality honeys demand specialised marketing and resources and opportunities are wasted by N.Z. exporters competing with each other to sell the same product into the same market.

The formation of an Exporters Association within the industry could provide a basis for more orderly and thus more profitable exporting activities. This organisation could undertake to provide support and recognition for responsible exporters, and to promote honey exports both within the country and overseas in our markets.

Co-ordination of exporting efforts, provision of information for existing and prospective exporters, promotion of export and production standards, lobbying of Government agencies for adequate export promotional support and legislation, and endorsement of recognised exporters are some of the areas of possible activity for such an organisation on behalf of the beekeeping industry.

Membership need not be restricted to NBA members, but should be limited to those with an active interest in the export market. It is suggested that the Executive would initially nominate members to establish the association,

then further recommendations or applications can be considered by the association in future.

Amendment that the word "recognised" be deleted.

The amendment was LOST 5-7.

Amendment that the words "NBA Executive" and "an Association" be deleted and replaced with "the New Zealand Honey Packers Association Inc" and "a group" respectively.

THAT THIS CONFERENCE RECOMMENDS TO EXECUTIVE THAT IT LOOK AT WHY THE LOWERING OF WORLD HONEY STOCKS HAS NOT CAUSED A SUBSTANTIAL INCREASE IN WORLD HONEY PRICES AND THEN USE ITS BEST ENDEAVOURS TO CURE THE PROBLEM

The motion was CARRIED 12.-1

12. SOUTH WESTERN DISTRICTS

THAT THIS CONFERENCE RECOMMENDS THAT THE EXECUTIVE INVESTIGATE THE FEASIBILITY OF ADVERTISING/SPONSORSHIP HOARDINGS BEING PLACED AT SPORTING AND/OR OTHER VENUES WHERE TV BROADCASTING TO A WIDE AUDIENCE WILL ENSURE, E.G. CRICKET AND RUGBY GROUNDS

FOOTNOTE: This could be a cost effective way of obtaining generic advertising for honey

The motion was LOST 2-10

18. WAIKATO

IT IS THE RECOMMENDATION OF THE CONFERENCE THAT EXECUTIVE SHOULD WORK IN WITH THE APPROPRIATE BODY IN THE IMPORTATION OF CLOVERS AND PLANTS, TO BENEFIT THE BEEKEEPING INDUSTRY, WHEN BEING BROUGHT IN FOR DROUGHT AREAS AND IN TRIALS FOR PASTURES THAT MAY NEED TO BE DEVELOPED DUE TO THE GREENHOUSE EFFECT ON OUR CLIMATE.

FOOTNOTE: In the past some Government Work Schemes have done a lot of damage to the Beekeeper, loss of willow etc! This is one way of helping to retrieve the situation.

Amendment that all the words after "pasture" be deleted.

The amendment was CARRIED 14-0

The amended motion was CARRIED 14-0

16. NELSON

THAT THIS CONFERENCE RECOMMENDS TO NBA EXECUTIVE THAT THEY IMPRESS ON THE GOVERNMENT OF N.Z. THE NEED TO FUND THE PROGRAMME OF ESTABLISHMENT OF THE WASP PARASITE SPHECOPHAGA VESPARUM FROM GOVERNMENT FUNDS RATHER THAN USER PAYS FUNDING.

FOOTNOTE: Wasps are now adversely affecting every sector of the community, particularly with the now widespread establishment of the common wasp (Vespula vulgaris). The Nelson Branch of NBA considers that it is vital that there be greatly increased funding for the parasite

establishment programme.
The branch also considers that
this is not a case for "user
pays" funding only, as all New
Zealanders in wasp infested
areas are affected.

Amendment that the words after the word "Fund" and before from government be deleted and replaced with "a wasp control programme"

REMITS:

13. WAIKATO

THAT THIS CONFERENCE RECOMMENDS TO EXECUTIVE THAT A SUM OF MONEY BE AVAILABLE EACH YEAR OUT OF THE HONEY INDUSTRY TRUST FUNDS FOR DISBURSEMENT, IN INCREMENTS OF ONE THOUSAND DOLLARS WITH A MAXIMUM OF TEN THOUSAND DOLLARS, FOR ANY ONE PROJECT WHICH HAS BEEN COMPLETED IN THE PAST YEAR AND WHICH IS DEEMED TO BE BENEFICIAL TO THE NEW ZEALAND BEEKEEPING INDUSTRY, BY THE VOTE OF THE BEEKEEPING INDUSTRY.

THE POSSIBLE RECIPIENTS OF GRANTS ARE TO MAKE APPLICATIONS TO THE NATIONAL BEEKEEPERS' ASSOCIATION ON THE SAME TIME SCALE AS REMITS TO CONFERENCE AND TO BE TREATED AS IF THEY WERE REMITS TO CONFERENCE, UNTIL VOTED ON AT CONFERENCE, WHEN THEY WOULD BECOME RECOMMENDATIONS TO THE INDUSTRY'S TRUST FUNDS TRUSTEES. AT CONFERENCE EACH BRANCH WOULD VOTE ON WHICH PROJECTS SHOULD RECEIVE A GRANT AND THEN SHOULD VOTE ON HOW MUCH THAT GRANT SHOULD BE.

FOOTNOTE: No restrictions as to who should apply e.g. government departments, individuals, companies, universities, NBA branches, overseas people etc.

The purpose behind this Remit is to encourage inventions, development of management procedures or anything that is beneficial to the New Zealand Beekeeping Industry and to encourage the Beekeepers to become aware of and make use of these advancements.

.

The fact that payments will be influenced by results, the value of the results to be judged by the beekeepers of New Zealand, will give great impetus to the development of our New Zealand Beekeeping Industry.

The motion was LOST 6-8 and upon a poll being called was LOST 478-542.

REMITS:

14. **EXECUTIVE**

THIS CONFERENCE RECOMMENDS THAT A LEVY BE ESTABLISHED SPECIFICALLY FOR THE PURPOSE OF MAINTAINING AND ENHANCING THE NBA BEEKEEPING INDUSTRY RESEARCH PROGRAMME.

FOOTNOTE: The remit has been prepared to encourage discussion within the industry towards the formation of a long-term research policy for the NBA and to gauge the attitude of NBA members towards present funding of research programmes.

> In response to withdrawal of direct Government funding, the NBA has established a valuable apicultural research capability over recent years. This has been done largely through financial assistance from the Industry Trust Funds, and joint funding arrangements with outside organisations such as MAF, DSIR and University Department.

The research carried out by these organisations and others, has already proved beneficial to our industry through improved pollination

services, disease diagnosis and treatment, bee health and nutrition developments, toxic substances research, pest control, honey quality analysis, live bee export capability, and market research development.

Under user-pays principles, there is a need for our industry to contribute some financial input to our research capability, and this attract additional joint - funding support from other agencies, particularly Government. We must also maintain our own ability to carry out and control necessary apicultural research in all areas, for both short and long term benefits to beekeepers.

Due to falling interest rates on investments, and inflationary decline of capital, the available funds from Industry Trusts are diminishing. The Trustees have also recently expressed concerned at the extent at which Trust funds are being allocated to Government based research organisations.

The NBA Research Advisory
Committee has undertaken to
explore all possible sources
of research funding other than
Trust Funds. A commitment
from NBA members through
establishing a Research Levy,
such as 10 cents per hive,
would enhance any application
for a matching allocation from
contestable Government
research funds, such as
through the Science
Foundation.

.

Any revenue collected in this way would be committed entirely to research support in any aspect of our industry including beekeeping practice, bee research, marketing and technical product development.

Amendment that the words "a levy be established" be deleted and replaced with "a percentage of the existing levy be allocated"

The amendment was LOST 1-13.

The motion was CARRIED 11-3

15. OTAGO

THIS CONFERENCE RECOMMENDS THAT NBA RESEARCH FUNDING MAY BE BETTER CHANNELLED IN DIRECTIONS WHERE RESEARCH IS NOT BEING DUPLICATED EITHER IN NEW ZEALAND OR OVERSEAS, AND IF RESEARCHERS IN ANOTHER COUNTRY ARE BETTER QUALIFIED IN DOING THE SAME RESEARCH, THEN THE NBA SHOULD SUPPORT THEM.

The motion was CARRIED 10-4.

using compounds which are restricted in their use in overseas countries for environmental reasons.

Already instances of negligent and overuse of dangerous chemicals have occurred in this country, and it is felt that an independent assessment should be made on the use and possible effects of such chemicals on our environment now and in the future.
