MINUTES OF A MEETING OF THE EXECUTIVE HELD IN THE DRUIDS' CLUB ROOMS, DRUIDS' CHAMBERS, CNR. WOODWARD STREET AND LAMBTON QUAY, WELLINGTON 1, ON 12TH MARCH 1973 AND CONTINUING ON 13TH AND 14TH MARCH 1973

PRESENT:

Mr I.J. Dickinson, President (in the Chair), Messrs J. Bray, M. Cloake, D. Penrose, E. Whalley. <u>In attendance</u>: E.R. Neal, Association Secretary, and M. Stanton, Editor of the "New Zealand Beekeeper".

OPENILIG:

Mr Dickinson welcomed members of the Executive. He said he trusted that it would be a successful meeting as there were important matters to discuss, including the draft of the amended H.M.A. Regulations.

DRAFT OF AMENDED The President said that there would be a meeting at the Ministry H.M.A.REGULATIONS: in Wellington during the period that the Executive were in

Wellington at which Messrs Poole and Eckroyd would represent the Honey Marketing Authority and the President, the Secretary of the Mational Beekeepers' Association and one member of the Executive would represent the Mational Beekeepers' Association, and Mr E. Lee would represent the Ministry.

OBITUARY:

The President said that he regretted to report the death of Mr W.W. Nelson. Members stood for one minute in memory of the late Mr Nelson.

MINUTES OF PREVIOUS MELETING:

Minutes of the meeting held on 5th December 1972 were considered. It was agreed that on page 7 the words "packing firms" should become "packers".

On the motion of Mr Whalley seconded Mr Cloake it was resolved that subject to the above correction to the Minutes, these Minutes which had been previously circulated to members be confirmed as being a true and correct record of the proceedings.

MATTERS ARISING OUT OF MLNUTES:



ACCOUNTS FOR PAYMENT: (a) <u>Noxious Weeds</u>: Mr Cloake reported that this matter was in progress and that he would be able to report to the next meeting. Mr Dickinson said there had been a meeting regarding noxious weeds held in Timaru in February.

(b) <u>Packers Association</u>: Mr Penrose said that a meeting had been held in Christchurch and he had gone along prepared to negotiate with members of the Executive of the Packers Association. He said he was unable to achieve any basis for a negotiation at that stage. Mr Haines and Mr Bray who are other members of the delegation endorsed Mr Penrose's report. It seemed that the area of difficulty was the representation wanted by the Packers. They wanted two members as of right on the N.B.A. Executive. Mr Bray said he felt that if the N.B.A. could give some sort of lead, the Packers Association would go out of existence. Mr Dickinson read a letter from the President of the Packers Association in this connection.

The Secretary tabled a list of accounts paid since the last meeting and needing authorisation together with a debit from the Editor for those not yet paid.

On the motion of Mr Whalley seconded Mr Penrose it was resolved that the Secretary's statement of cheques drawn be received and that payments made since the last meeting be ratified and that the payment to the Editor of \$112.35 be authorised.

RETURNING OFFICER The Secretary referred to a letter that he had received from the FOR H.M.A. General Manager of the H.M.A., a copy of which had been sent to the President. The tenor of the letter was that before the N.B.A. appointed the Returning Officer for the Honey Marketing Authority elections for 1973, the N.B.A. should seek an undertaking from the Returning Officer elect that he would stipulate a fee to be charged and would undertake to stay within that fee. The Secretary recapitulated the circumstances surrounding the 1972 and 1970 elections where he had been Returning Officer and mentioned some of the time consuming problems that had arisen. The Secretary said that he was quite unable to accept a position where his responsibility was unlimited and yet his fee was limited. Mr Cloake moved and Mr Bray seconded a motion that Eric Robinson Neal be appointed as Returning Officer for the 1973 Honey Marketing Authority elections. Mr Bray moved and Mr Whalley seconded an anendment that the words "and that it be pointed out to the Honey Marketing Authority that

"and that it be pointed out to the Honey Marketing Authority that the decision of Mr Alan Dick the then Parliamentary Under-Secretary for Agriculture appeared to be ultra vires the Honey Marketing Authority Regulations" be added.

The addendum, when put, was carried and the substantive motion when put was carried.

PRESIDENTIAL On LETTER TO THE NET HONEY MARKET Au ING AUTHORITY: "N

On the motion of Mr Whalley seconded Mr Bray it was <u>resolved</u> that Mr Dickinson's letter of 18th January 1973 to the Honey Marketing Authority which was subsequently published in the February "New Zealand Beekeeper" be confirmed and endorsed.

COMB HONEY ASSOCIATION: A letter had been received that morning from the Comb Honey Association. It was agreed that the letter be received and replied to after a consideration of the draft regulations.

DEPARTMENTAL:

An Agenda for discussion by the Departmental Officers was then drawn up and covered thirteen items which were dealt with later on in the meeting.

<u>N.Z. BEEKEEPER</u>: Mr Stanton said that it was his intention, if Executive so approved, to send to registered beekeepers who were not subscribers or members of the Association a gratuitous copy of the May "Beekeeper". On the motion of Mr Penrose seconded Mr Bray it was <u>resolved</u> that the Executive authorise the Editor to print approximately 1,000 extra of the May issue of the "New Zealand Beekeeper" and that these be distributed to non-members of the Association together with an explanatory leaflet.

PATMENT FOR CONTRIBUTIONS TO THE N.Z. BEEKEEPER On the motion of Mr Penrose seconded Mr Bray it was <u>resolved</u> that suitable contributions from Beekeepers to the "New Zealand Beekeeper" be paid for at nominal fees.

FORMAT AND CONTENT OF THE N.Z. BEEKEEPER:

The present Editor sought opinions of members as to the format and content of the "New Zealand Beekeeper". : On the motion of Mr Dickinson seconded Mr Penrose it was <u>resolved</u>

that the Editor be complimented on his first two issues of the "New Zealand Beekeeper" and that he be asked not to make any changes.

CONFERENCE 1973: On the motion of Mr Whalley seconded Mr Bray it was resolved that the Conference be held on the 11th, 12th and 13th July 1973, subject to Nelson Branch's approval as to dates, and that if there was any local difficulty with these dates a second choice of dates be the 4th, 5th and 6th July.

NOTES FOR RUNNLNG CONFERENCES:

Mr Penrose congratulated Mr Haines on the notes he had drawn up for the guidance of those branches running conferences and which had already been supplied to Nelson Branch. It was agreed that the Secretary write to Nelson Branch reminding them to supply details of the conference arrangements for the May issue of the "New Zealand Beekeeper". It was agreed that the business session of conference be from 10.00 a.m. on the Wednesday to 1.00 p.m. on the Friday and these times be strictly adhered to. It was agreed that insofar as delegates' votes

were concorned, pre-printed forms be prepared by the Secretary.

EXECUTIVE MEETING PRIOR

Notes were taken by the Secretary of members! wives who would be attending and the mode of transport Executive would be using. TO CONFERENCE: It was agreed that the Executive Meeting start at 2.00 p.m. on the Monday preceding Conference. The President said that in view of the start at 2.00 p.m. on the Monday, there would be exactly a day and a half in which to transact business because, in his opinion, it was very ill-advised to meet at night with the heavy work of a conference coming up. He therefore urged members to get matters in for the pre-conference Executive Meeting Agenda to the Secretary as soon as possible.

PRINTING & STATIONERY:

The Secretary reported that stationery was getting very low. On the motion of Mr Whalley seconded Mr Bray it was resolved that the Secretary be authorised to have printed a quantity of Association Life Certificates and a quantity of Branch Life Certificates.

TINS EX ALEX HARVEY:

Mr Dickinson said he had received a communication from a Mr Marsh expressing concern at delivery of tins without lids being affixed. Mr Penrose suggested that there should be an article in the Journal advising members that they should specify that lids be put on tins before delivery.

On the motion of Mr Penrose seconded Mr Whalley it was resolved that ALTERNATIVE MARKETING this matter lie on the table until Wednesday morning. SCHEME (COMMONLY

HIVES NEAR ROADSIDES: Mr Haines said that there had been particular problems in his area. There were numerous complaints in respect of hives being near roadsides and children were getting stung. The local Council had asked the beekeeper to shift them and the Council had said that they would This was referred back to Mr Haines to not shift them themselves. take up with his local branch.

TOUR OF CANADA:

Mr Haines said that there was a projected tour of Canada for beekeepers in winter 1974. On the motion of Mr Penrose seconded Mr Whalley it was resolved that Mr Haines be appointed as a sub-committee of one to bring down a report to the Executive meeting priod to Conference on a suggested tour of Canada.

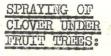
METRIC MEASUREMENTS:



Mr Dickinson said that he had discussed this with the General Manager of the H.M.A. It appeared that the deadline was 1976 for the changeover, which gave some time for re-adjustment. On the motion of Mr Dickinson seconded Mr Whalley it was resolved that the letter from the Honey Packers regarding metric measurement be received and they be advised that this was in accordance with the wishes of Executive, except that quantity measurements should be converted to weight measurements.

LOANS:

STATE ADVANCES It was thought that the limit was still \$10,000 and perhaps this should be raised. On the motion of Mr Haines it was resolved that the Secretary ask State Advances whether there was any limit applying to State Advances loans to beekeepers, or whether each case was judged on its merits.



Mr Bray reported that a queen breeder had lost all of his queen nuclei bees after spraying of fruit trees in late December. He wondered whether there was any repellent that could be put in with the spray. Referred to Mr Smaellie.

ADJOURNMENT:

The meeting was adjourned at 5.57 p.m.

BEES BY AIR:

It was thought that the Mayor and Mayoress of Nelson would welcome delegates, and it was agreed that Mr Penrose make arrangements re this. On the motion of Mr Dickinson seconded Mr Whalley it was resolved that Mr Penrose be appointed a sub-committee of one to liaise with Nelson Branch re all aspects of the Conference.

On the motion of Mr Bray seconded Mr Penrose it was resolved that a Minister of the Crown be approached with the following preferences

At this stage, Mr Dickinson withdrew from the meeting to confer with Mr Poole.

Mr Penrose assumed the Chair.

WELLINGTON ACCOMMODATION:

It was agreed that this matter lie on the table.

MISLEADING ADVERTISING: It was reported that "Soil" magazine had carried an advertisement advertising creamed honey that contained no glucose or icing sugar. On the motion of Mr Bray seconded Mr Whalley it was resolved that the Editor write a letter to the Editor of "Soil and Health" magazine pointing out the implications of the advertisement in question. Mr Haines moved that a letter be written to the "New Zealand Herald" regarding an advertisement which contained the words "absolute purity". This lapsed for want of a seconder.

SEMINAR FINANCES: Mr Cloake reported that he had handed \$180 to the Secretary which represented the profit from the Timaru Seminar less \$10 which had been kept against contingencies. There had also been a cheque stopped by a person who did not attend the Seminar. On the motion of Mr Cloake seconded Mr Bray it was resolved that the Seminar fund be funded. On the motion of Mr Bray seconded Mr Cloake it was resolved that the Seminar and Bursary accounts be funded on fixed deposit at the Bank of N.S.W. and that the signing authorities be as per the No. 1 Account.

SEMINAR:

Mr Cloake said he had endeavoured to have as much of the Seminar proceedings and papers published in the "New Zealand Beekeeper" as possible. However, he thought that Graeme Walton's address at the 1972 Seminar should be sent out to members.

At this stage Mr Dickinson resumed the Chair.

The meeting adjourned at 12.30 p.m. for lunch.

RESUMPTION:

The meeting resumed at 1.45 p.m.

WELLINGTON On the motion of Mr Penrose seconded Mr Haines, it was resolved that ACCOMMODATION: the matter of the Wellington accommodation be lifted off the table, and after a survey of the tariffs that the Midland Hotel be utilized in future as the most economical accommodation.

DEPARTMENTAL:

At 2.30 p.m. Mr Smaellie arrived and offered apologies for Mr Watt. The following was discussed:

1. Grading at Southland Depot: the N.B.A. thought that this was in arrears. Mr Smaellie said that Mr Cook was caretaking at the Southland Depot for urgent work. Whilst it seemed that some of the

work had fallen into arrears, the situation was now under control.

2. Noxious Weeds: Mr Smaellie said he knew very little about this except that it was in the melting pot. A Mr Hadfield of the Department was on the Noxious Weeds Committee, whose purpose it was, Mr Smaellie understood, to generally tidy up the legislation. It was agreed that the Secretary write to Mr Hadfield of the Advisory Services Committee.

3. Future Organization of Seminars: Mr Dickinson said the N.B.A. was contemplating a Seminar in the North Island in 1974.

4. The Agricultural Advisory Officer at Christchurch: Mr Bray said he understood that the present officer had been there for six months and he wondered what procedure was necessary to requisition work on that officer. Mr Smaellie said that the officer had a work programme which was formulated 12 months ahead. Beekeepers or the N.B.A. requiring work to be done should approach the officer concerned.

5. Honey House Regulations: Mr Smaellie said that he had already rung the Health Department to check on the progress of the legislation. A Mr Cook at the Health Department had said that they had the Regulations with the Law Draughtsman. In the meantime, the Department of Agriculture was carrying on the policing of the honey houses.

6. Destruction of Wasps: Mr Smaellie said that there had been no more progress except that they were still working on baits. There still seemed to be no better methods. Mr Dickinson wondered why the Department could not take the responsibility of destroying wasps. Mr Smaellie said that the Department accepted the responsibility for giving advice but would not carry out the destruction.

7. Importation of Queen Bees from Tonga: Mr Smaellie said the importation could not be accepted by the Department as it was too risky. They could not recognize Mr-Walsh's report as an "in-depth" investigation. They had found a mite about which nothing was known on queen bees at Tonga. It was just big enough to see with the naked eye. Mr Smaellie said it was the Department's opinion that two or three mites to a bee would make the bee very sick. He also said the Bird Life and Horticultural people were not prepared to allow the importation because they did not think there was enough economical importance to justify the expense.

8. Extra copies of "New Zealand Beekeeper": Mr Smaellie was invited to send a list of the extra copies of the "Beekeeper" needed by departmental officers.

9. Features for the "New Zealand Beekeeper" ex departmental officers: Mr Smaellie said that this seemed to find its own level in regard to contributions. He always encouraged officers to write articles.

10. "Beekeeping in New Zealand": Mr Smaellie said he was most frustrated that this was out of print. It was at present at the Government Printer but he wondered whether priority may have slipped in relation to other legislation and work. Mr Penrose said he thought some of the plates could be broguht up-to-date. Mr Smaellie said they could not do much with the original material. He had initiated arrangements whereby a completely new bulletin would eventually be produced.

11. Repellents with Sprays: Mr Smaellie said there was no satisfactory solution to date. The Department, through Mr Palmer Jones, had the problem steadily in front of them.

12. Conference Papers: Mr Dickinson said that all departmental conference papers should be received by the N.B.A. well in advance of the Conference so that these could be printed and distributed.

13. Honey Dew Regulations: Mr Smaellie said he was working on this assiduously. The regulations were to control the quality of exports. One set of regulations for honey and another for honey dow could not be entertained.

At 3.40 p.m., Mr Smaellie withdrew.

At 4.40 p.m. Mr Poole and Mr Ekroyd from the Honey Marketing Authority arrived and reported on their meeting with the Minister.

At this stage the meeting adjourned at 5.40 p.m.

7.

RESUMPTION:

The meeting resumed at 9.45 a.m. on Wednesday, 14th March 1973. Mr Dickinson said it had been suggested in view of what Mr Poole had said about the lower pay-out that approaches should be made to Mr Pryde of Federated Farmers. On the motion of Mr Bray seconded Mr Whalley it was resolved that the action of the Chairman in co-opting Mr R.F. Poole, Chairman of the Honey Marketing Authority as a sub-committee of one to approach Mr Pryde, the General Secretary of Federated Farmers, re the Industry's difficulties with the present Government's actions relating to marketing be confirmed. Mr Dickinson then gave az brief report on the meeting of the night before.

EDITOR'S SALARY:

RULES:

On the motion of Mr Penrose seconded Mr Cloake it was resolved that

Conference asked that the Berry/Belin resolution re delegates votes recording majority and minority votes be implemented. On the motion of Mr Dickinson seconded Mr Penrose it was resolved that the rule read:

"28. (ee) On a poll each delegate shall have one vote for each full dollar of annual subscription of financial members actually present at the Branch Meeting empowering the delegate and that both majority and minority votes be recorded in the delegates ' votes at Conference."

On the motion of Mr Dickinson seconded Mr Haines it was resolved that Remit 31 by the Executive from the 1972 Remit Paper re Rule 9a be fully presented as a remit in 1973.

On the motion of Mr Penrose, seconded Mr Whalley, it was resolved that Executive prepare a remit for the next Conference that Rule 30 be altered to delete "one voteonly" and substitute "one vote for each full dollar of annual subscription actually paid by him in the preceding financial year".

On the motion of Mr Cloake seconded Mr Haines it was resolved that Executive prepare a notice of motion for presentation at the 1973 Annual General Meeting that all subscriptions be subject to a surcharge of \$2 per annum throughout the whole scale effective as soon as possible under the rules.

On the motion of Mr Penrose seconded Mr Whalley it was resolved that a sub-committee of the Executive be set up with power to co-opt members to deal with all matters pertaining to packing honey. On the motion of Mr Penrose seconded Mr Bray it was resolved that a sub-committee of the Executive be set up with power to co-opt members to deal with all matters pertaining to queen breeders.

ANNUAL REPORT: The Secretary was asked to prepare a short report under the rules.

QUEEN BREEDERS On the motion of Mr Penrose seconded Mr Whalley it was resolved that SUB-COMMITTEE: Mr Haines be Convenor of the Queen Breeders Sub-Committee.

ALTERNATIVE

Mr Cloake felt it was pointless to discuss this because of the Government's attitude. Mr Dickinson moved and Mr Cloake seconded a motion that no further action be taken on the alternative (peroyd Scheme). Mr Whalley moved and Mr Bray seconded an amendment that EROYD SCHEME): the word "further" be replaced by the word "immediate". When the amendment was put it was carried and the substantive motion when put was carried.

On the motion of Mr Bray seconded Mr Cloake it was resolved that Waikato Branch's resolution re a postal ballot not be proceeded with in view of subsequent conference decisions re the levy.

MELSON BRANCH: The Secretary reported that he had written to Nelson about issuing statements and communicating with the Broadcasting Corporation.

## IN COMMITTEE:

PROPOSED AMENDED	Mr Dickinson said these were to be of great importance to the sindustry. There had been a lot of divided opinions. There were the wishes of the Industry as expressed at Conference and they should be a proper and correct extension of the wishes of Conference. Mr Dickinson moved and Mr Cloake seconded a notion that the Executive's representatives to the joint meeting with the Department of Agriculture and the Honey Marketing Authority at the Ministry pursue the wishes of Conference 1972 - i.e., that the present seals levy be retained and extended to cover all other extracted honey and paid at the point of sale by declaration. Mr Whalley moved an amendment that the words "In view of changed market circumstances that there be a review of the rate of levy" be added to the present notion. This lapsed for want of a seconder. When the unaltered original notion was put, there were two for and four against and the notion was there- fore declared Lost.
DRAFT AMENDMENTS TO H.M.A. REGULATIONS:	On the notion of Mr Bray seconded Mr Whalley it was <u>resolved</u> that the text be altered by adding the words "by the producer" between "payable" and "on", and adding the words "extracted" between "all" and "honey", and by adding the words "at the point of sale" after "Zealand". This refers to 20(1). On the notion of Mr Penrose seconded Mr Haines, it was <u>resolved</u> that all words after "30th day of June" be deleted. This refers to 20(1). On the notion of Mr Penrose seconded Mr Whalley, it was <u>resolved</u> that the word "sold" be used instead of "produced" on the third line of 21(2). On the notion of Mr Bray seconded Mr Whalley, it was <u>resolved</u> that all references to 1000 kilos be 500 kilos. On the notion of Mr Cloake seconded Mr Penrose, it was <u>resolved</u> that the exemption be applicable to 500 kilos or less, not the first 500 kilos.
DRAFT AMENDMENTS TO H.M.A. REGULATIONS:	On the notion of Mr Bray seconded Mr Whalley, it was <u>resolved</u> that the word "proportionate" be inserted between the word "the" and the word "anount" in 21(5).
DEPARTMENTAL:	Vacant Apiary Instructor's Job: Mr Snaellie said that they had had some applicants applying but they were waiting for more suitable candidates. Mr Penrose wondered whether the salary scales advertised in the "New Zealand Beekeeper" were maximum ones.

His recommendation was that the Association contact the Director General of the Ministry of Agriculture & Fisheries in this respect.

- f) Mr. Smaellie reported that in February 1973 there had been a case of Toxic Honey poisoning.
- g) Mr. Smaellie reported that Honey Export Regulations were being amended.
- METRICATION: On the motion of Mr. Penrose seconded Mr. Cloake it was resolved that it be a recommendation from Executive that the incoming executive set up a sub committee to liaise with the Ministry, Manufacturers and other interested parties on Metrication.

COMB HONEY At 4.10 p.m. Mrs. Wright, Mr. Bellin and Mr. Blair attended. ASSOCIATION: Mr. Dickinson asked that the Comb Honey Association put forward a case for exclusion from the levy so it could be discussed by executive. It was agreed that the President attend a meeting of the Comb Honey Association.

**RESIGNATION OF** The President reported a resignation from the General Secretary **GENERAL** dated the 9th July 1973 giving three months' notice. In **SECRETARY:** speaking to this the Secretary said there were two reasons for his resignation - 1) the low level of fees paid to his Practice; and secondly the frustration that he had experienced with the lack of progress that the Association was making.

On the motion of Mr. Penrose seconded Mr. Haines it was <u>resolved</u> that executive accept Mr. Neal's resignation with regret and thank him for the time and effort put in for the benefit of the Association.

Conference with manufacturers in some specific instances where the manufacturers were not holding adequate stock and there had been specific instances with Mr. Heinneman of Milburn, South Otago, Mr. Haines of Kaitaia and Mr. Marsh of Central Otago, having up to six weeks delay in delivery or no date of the order being fulfilled. MINUTES OF

Mr Dickinson welcomed members of the executive. He said the Association had been involved in a number of serious matters and there was a grave situation in regard to;

a) The levy proposals and

Mr I.J. Dickinson (In the Chair)

In attendance: E.R. Neal Association Secretary N. Stanton, Editor of "The New Zealand Beekeeper".

b) The limit of payout.

He thought the executive must show strength and confidence, both in itself and to outside bodies.

Mr Dickinson went on to say that he would stress the sentiments in a recent memo he had sent to executive complaining about lack of communication. It was very necessary for executive to correspond regularly. Mr Dickinson said he found difficulty in knowing how the Packers of honey, Queen Breeders etc., felt when he was solely a producer. He would ask anyone who had anything of moment to communicate, to drop a note to him.

Mr Cloake suggested an amendment on the last page regarding the Health "Packing Houses" should read "extraction Houses". PREVIOUS MEETING: Department.

> On the motion of Mr Penrose and seconded Mr Cloake it was resolved that the minutes of the 10, 11, and 12 September as previously circulated, and as amended above, be confirmed as being a true and correct record of the proceedings.

The Secretary then read three sets of confidential minutes which had been taken "in committee" and for which only two copies had been produced, one for the President and one copy pasted in the minute book.

On the motion of Mr Haines, seconded Mr Lorimer it was resolved that the three sets of "in committee" minutes taken on the 10, 11, and 12 September meeting and as read by the Secretary be confirmed as being a true and correct record of proceedings.

1) Survey of Wages: The Secretary reported that he had been unable to commence this exercise.

2) Dale and correspondence to the Minister: Mr Dickinson said Mr Dale had intended writing to the Secretary regarding any embarrassments that might have been caused. The Secretary reported that no such correspondence had been received.

3) Honey Mead: The Secretary reported on phone calls he had had with Mr Havill and Mr Noslen, and information he had passed from one to another regarding Health Department authority to make mead.

4) October meeting with the H.M.A.: Mr Dickinson reported that only he had attended and not two representatives as originally envisaged.

Mr Dickinson reported that the previous day he had had an hour and a quarter's meeting with the Minister. He had to report that discussions were not concluded and there would be another meeting next Wednesday the 19 December 1973 at 11.00 a.m. Mr Dickinson said he had left home on Sunday and conferred with the Chairman of the H.M.A. on the Sunday evening at Christchurch, discussing the situation with him fully. He had had every co-operation from the Chairman of the H.M.A. with regard to information on finance, market trends. According to the H.M.A. there was every indication that the realisations would be down 10-15%.

MATTERS ARISING OUT OF MINUTES:

LIMITED PAYOUT:

This would represent a drop in the 1973/74 realisations compared with those for 1972/73. Factors taken into consideration in assessing this allowed for re-valuation of the New Zealand dollar, the fact that Japan had stockpiles of honey to last at least until April 1974, the fact that general trends for the Honey market tended to level out and the situation regarding oil shortages and the effect this would have on shipping and on production.

The Chairman of the H.M.A. and Mr Dickinson had considered all aspects they would discuss with Mr Barclay. Mr Dickinson had thought that the things which would loom large in Mr Barclay's mind would be the effect on the Consumer and the effect on the Packers if all of the realisations were paid out. In the event, at the meeting safeguards for the Consumer and the Packer were to the forefront of Mr Barclay's mind. One suggestion originating from Mr Dickinson and Mr Poole was that perhaps a "base price" be set which would give the H.M.A. a certain amount of autonomy with which to dispose of realisations over this base price. Mr Barclay seemed receptive to this suggestion. It was also suggested to Mr Barclay that 25 cents could perhaps be the base price for 1973/74 and Mr Barclay said 10-15% off previous realisations of 28 cents was pretty close. Mr Barclay had wondered whether 23 cents should be the frist base price. In any case he was very interested in the concept of a base price. It would seem that with a base price, the supplier would know what was to happen. It was also suggested that half of the difference between the base price and the realisation be paid to the supplier as an extra and the other half be put to reserves. Mr Barclay seemed to like this scheme also. If however the realisations were below the base price and reserves had to be utilised to bolster up the payout then the next year, the base price might have to be lowered. However, it was hoped that next year a cost of production scheme would be in operation and information from it would help regulate the base price. One great advantage to the suppliers would be that they would have a "early warning system" of price fluctuations. Mr Dickinson said he would recommend later to the executive that 24 cents be the base price.

On the motion of Mr Penrose, seconded Mr De Wit it was <u>resolved</u> that the executive of the N.B.A. ratify Mr Dickinson's negotiations with Mr Barclay and the Honey Marketing Authority to date regarding the payout and that on the 19 December 1973 Mr Dickinson promote the concept of a "base average price" and also a concept of the Honey Marketing Authority having power to pay out at least half of the surplus of realisations over the base average price to the suppliers.

ADJOURNMENT:

RESUMPTION:

At this stage, the meeting adjourned for lunch at 12.41 p.m.

The meeting resumed at 1.45 p.m.

After further discussion on the payout, on the motion of Mr Penrose, seconded Mr Haines it was <u>resolved</u> that the National Executive of the N.B.A. recommend that the base average price payout be 24 cents.

Mr Lorimer raised the question of the amounts put to reserve going to the credit of individual suppliers. This was taken up later in the meeting, since at this stage, Mr Watt and Mr E.W. Lee arrived.

COST OF PRODUCT-ION SURVEY: Mr Dickinson welcomed Mr J. Watt from the Ministry and Mr E.W. Lee from the Minintry. He said it was good to have the association with the Ministry especially in respect of the advice and assistance the Association hoped to get in connection with the mounting of Cost of Production Surveys as these had a bearing on so much of the industry's welfare. Mr Watt said in general the Ministry had abandoned Cost of Production surveys in favour of market trend surveys. Mr Watt said he had people in his Ministry who he was sure could assist the N.B.A. conduct a Cost of Production Survey. There was a long discussion with Mr Watt and Mr Lee with members of the executive asking various questions. Mr Watt said there was a Mr Smith in the Ministry at Christchurch who would help construct a scientifically designed Cost of Production procedure, and that the N.B.A. should make contact with him as he has the authority to assist where ever he can.

RESEARCH . TOPICS: Mr Penrose said that there were often research topics which came up. Mr Penrose asked whether Mr Watt would consider it impertinent if the N.B.A. suggested lines of research, especially when commercial bee operators had done some work towards this research. Mr Watt replied that his Ministry would welcome it. Mr Lorimer then quoted the example of Mr Palmer-Jones undertaking some research in regard to the feeding of sugar to bees and using A1 sugar only instead of doing trials on both A1 and raw sugar at the same time.

There was a very long discussion which the President described as being very fruitful.

Mr Dickinson moved and Mr Cloake seconded a motion that this executive do not consider that the time is opportune for the formation of sub committees with a direct representation on this executive.

Mr Penrose said he would have to speak against this; if it succeeded the N.B.A. would be burning its bridges behind it. The way the Government was going the Industry must have unity. Sub sections within Branches would be better still, and would be entirely different to re-structuring the entire Body. The central issue was direct representation. Meetings throughout the Country provided ample opportunity for this. Sectional interests could use the N.B.A. to advantage by attending meetings. All had the machinery for this purpose. They could make it their business if they placed their problems before their branches. Mr Haines said he would oppose the motion. Whilst the machinery was inadequate the Packers and the Queen Ereeders Groups were spread throughout the country. There might only be one in each branch; if sections had their own meetings they could formulate their own remits etc. This must benefit industry if kept in right context and so long as producers could not be out voted.

Mr Cloake said he would oppose on the grounds of representation. He agreed on the sub committees however. He said the sub sections had access to the executive now. Past executives had had people who had had these various industry backgrounds. He thought also that the move would do nothing to stop unauthorised representation to Government. Some "knockers on doors" had been executive members. He wondered whether the Minister took more notice of these people than executive were lead to believe. Forming an Association to stop this would just not work. At the present time the N.B.A. had strength to handle these problems. He said he would be prepared to handle the proposition in say, a year's time.

He posed the question if a Queen Breeders Group was allowed to be formed, why not allow South Canterbury Honey Producers Group or a Kamahi Producers Group or a Clover Honey Producers Group. Mr Dickinson said he considered the time was opportune and recommendations should be put to conference. He had strong reservations on the representation for ten or twelve persons, however. Nevertheless he did feel that there was a strong need to have available at executive level, representations from the stronger sub interests. If executive had this representation there was a strong possibility the sub sections would prove to be unnecessary. He thought it was the time to think seriously and make recommendations to the forthcoming conference. Mr Dickinson had found it most difficult, as he said in his memo, to get up to date information. On two or three occasions he had received information regarding what a certain organisation was doing. He wondered why he had not heard earlier. Two cases in point were metrication and the M.R.P. When the motion was put, there were two for and four against and the motion was therefore lost.

Mr Penrose moved and Mr Haines seconded a motion that it be an executive remit to conference that rule 18 (a) be altered to read in line 2, nine (9) instead of six (6); line 2, two instead of one; in line 3, six instead of four; in line 3, one instead of two and in rule 18 (b) in line 1, nine instead of six and in rule 18 (a) and the words "and one from each of the Queen Breeders, Honey Packers, Comb Honey Producers, Honey Dew Producers, sub committees of the Association", be added; and in rule 18 (b) adding the words "Taking each Island and each of the Queen Breeders, Honey Packers, Comb Honey Producers, Honey Dew Producers elections as separate elections and that at least two persons shall be nominated for the Queen Breeders Honey Packers, Comb Honey Products, and Honey Dew Producers sub committee of the Association"

Mr Dickinson moved and Mr De Wit seconded an amendment that the words "one from each Island" be added after the words "vice presidents". When the amendment was put it was <u>carried</u>.

When the substantive motion was put it was carried.

Messrs Cloake and Lorimer asked for their dissenting votes to be recorded. Mr Penrose then reported on the formation of a Honey Dew Producers Association.

ADJOURNMENT:

The meeting adjourned at 12.42 p.m. for lunch.

On the motion of Mr Haines, seconded Mr Penrose it was <u>resolved</u> that the Secretary's statement be received and the accounts paid now be ratified.

NEW ZEALAND BEEKEEPER: Mr Stanton reported on difficulties with the printer of the Beekeeping Journal.

At 2.21 p.m. with the permission of the President Mr Stanton withdrew to return to Auckland.

PETROL RESTRICTIONS: On the motion of Mr Penrose seconded Mr Haines it was resolved that the Secretary write to the Ministry of Transport with a copy to the Federated Farmers pointing out the position held by the Beekeeping Industry as primary industry and the way in which they depended upon petroleum products for their livelihood and seeking for consideration in the event of any restriction on petroleum products.

BOILER INSPECTION: Mr De Wit pointed out that generally beekeepers used their boilers for approximately 42 days per year. They are required to have the boiler inspected annually at present. On the motion of Mr De Wit seconded Mr Lorimer it was <u>resolved</u> that the Ministry of Transport and Marine Section be asked to amend the regulations so that Beekeepers' Boilers be inspected every two years instead of annually.

DANGEROUS GOODS C

Carried forward to next meeting.

LICENCES:

HEAVY TRAFFIC WAYBILLS: Mr Cloake pointed out that the Traffic Officers seemed to expect Heavy Traffic Waybills when Beekeepers were carting their own bees. It appeared that farmers were required to carry a heavy traffic waybill if carrying over  $5\frac{1}{2}$  tons.

On the motion of Mr Dickinson seconded Mr De Wit it was resolved that the Secretary write to the Ministry of Transport seeking clarification on the regulations re firstly, heavy traffic waybills and secondly goods licences in relation to Apiarists.

AGEICUL/TURAL Mr Lorimer said that Waikato Branch felt the submissions should be <u>CHEMICALS</u>: made to the Minister in connection with the proposed new regulations regarding the constitution of the Agricultural Chemicals Board.

> On the motion of Mr Penrose seconded Mr Lorimer it was <u>resolved</u> that Mr J. Fraser appointed as the representative to follow Mr Pearson on the Agricultural Chemicals Board and copies of the lotters from Mr Moyle sent to Mr J. Fraser for study.

At 3.00 p.m. Mr M.D. Cloake with the permission of the President withdrew.

BOOM LOADERS:

It appeared that the maximum allowed was 12 foot from the centre of the back axle.

On the motion of Mr Lorimer seconded Mr Haines it was <u>resolved</u> that the Secretary write to the Ministry of Transport regarding overlength booms to see if the Ministry will allow dispensation in individual cases. It was noted that Mr Lorimer would send details to the Secretary in this respect.

CANADIAN TOUR:

Mr Haines said he had the final details on the tour. This would cost \$1169 for sharing a twin berth and \$1319 single. These fares were all

inclusive except that they excluded the evening meal.

On the motion of Mr Dickinson seconded Mr Penrose it was <u>resolved</u> that Mr Haines be empowered to promote the Canadian tour provided there is no cost to the  $N_{\cdot}B_{\cdot}A_{\cdot}$ 

Mr Penrose wondered whether a Bursar should come to New Zealand from Canada. Mr Lorimer said it was high time we did something about this question.

On the motion of Mr Lorimer seconded Mr Penrose it was <u>resolved</u> that Mr Haines be empowered to arrange for the hosting of a Canadian Bursar prior to the Secretary inviting him.

LETTER FROM MR APPLETON: Mr Appleton had written about coming to New Zealand and staying with Beekeepers.

On the motion of Mr Dickinson seconded Mr Haines it was <u>resolved</u> that Mr Appleton's letter be forwarded to the Editor for publication in the "Beekeeper" in a condensed form.

CONFERENCE 74:

74: Mr Haines reported that he had talked to Mr Kevin Morris the organising officer of South Western Districts. The conference would be held at the Centennial Hall which had the public relations office in the front. There were facilities for typing, duplicating, there was a public address system built into the hall and there was a hotel just across the street from the hall, which had adequate accommodation.

DATE OF NEXT MEETING: On the motion of Mr Haines seconded Mr Penrose it was resolved that Wednesday, Thursday and Friday the 13, 14 and 15 March 1974 be the date for the next executive meeting.

CLOSURE:

There being no further business, the meeting terminated at 3.55 p.m.
