### EDITORIAL:

This year it would be true to say that all Members of our Association received a considerable crop of honey, together with the majority of honey producers. It would be true to say also that the majority of honey packers offered high prices for any honey they purchased during the year, and in this way were committed to charging a stable price on the New Zealand market. The crunch point for the majority of packers came later in the year when they discovered that considerable specials were being given to the retail trade by many smaller producers who overnight became packers, and by packers who found themselves forced to sell at reduced prices due to the flood of honey on the New Zealand market.

The answer to the problem would have been to export but this is not an overnight operation and although some packers have been able to find export markets for packed lines, it would appear that a better liason could be accomplished by the New Zealand Honey Marketing Authority advising standard prices to various markets so that honey packers were then able to contact overseas buyers knowing that the minimum price provided by the New Zealand Honey Marketing Authority for those markets were in fact in line with New Zealand Honey Marketing Authority policy. The problem is that packers are unsure.

One large chain of retail stores has run a regular special on 500 gram packs, advising their members to purchase at the best possible price and reducing the retail price to 59 cents. The fact that it has been possible for these stores to purchase honey at these prices creates a situation whereby in the end the beekeeper suffers and the consumer gains the opinion that honey is overpriced on the market.

It would be fair comment to say that the beekeeper is his own worst enemy. This applies also with the fact that as a group we could control our purchasing of containers, so that we could buy at reduced rates. Unfortunately beekeepers are traditionally individualists and at this stage it would appear that the Industry is not ready to operate any form of co-operative buying, and this has been examplified with the 2 Kg container where some of our members do not buy the Reese container.

The same situation has been shown where this Association at a meeting, where the new 500g plastic pottle was discussed and promoted by Frank M Winstone Ltd and Plastic Products Moulding Co Ltd, and members decided that they would back the Plastic Moulding Company product due to better presentation at the meeting, and the fact that is was priced considerably lower than the Frank M Winstone Ltd container.

However, to date only one order has been placed with Plastic Products and it is understood that orders have been placed with Frank M Winstone Ltd for the plastic pottle.

If members are desirous of obtaining better prices by bulk buying methods, then it is essential that they fully back any moves made by this Association in this direction as the efforts which are put into obtaining these better deals by your Executive cost the Executive members not only time and effort but also financial outlay.

This Association now has a credit balance in the Trading Bank of some \$3700. This amount has been brought about by co-operation and goes to prove the point that such co-operation can also save the individual beekeeper large sums of money in his normal trading operation.

#### NOTE:

It is with regret that I have not been able to publish regular Bulletins this year, mainly due to pressure of business. However no members have written any letters for publication or requested information.

The amendment is requested because the Association believes that the 6 kg pack is commonly requested for retail supply and is an economic weight, and one that could not be construed as a bulk supply. Further, it is understood that the 6 kg pack is currently being used by the meat industry for exports of liver products.

I refer to your letter of 22 May and my reply of 29 May concerning the inclusion of packed honey lines within the increased exports taxation incentive.

I am pleased to inform you that the Export Incentives Committee has supported the inclusion of the above honey products within the incentive and that the Committee's decision has now been endorsed by the Ministers of Overseas Trade and Finance.

A full definition of the products is likely to be adopted for the purposes of the legislation is "packed retail lines of extracted honey weighing 3 kg nett or less". If you do not consider that this definition is suitable could you please contact me as soon as possible to discuss suggested changes.

The inclusion of these honey products within the incentive will be effected shortly by Order in Council and will be applicable from 1 April 1978. It would be appreciated if you could inform your members of this decision.

I have been asked to write to you concerning the existing weight limits on honey taken out of the country by tourists returning overseas.

It is considered that the present limit of 5 Kg is inadequate as New Zealand Honey is proving extremely popular with overseas tourists, who are voicing their displeasure at being unable to take more of our honey home with them.

This Association suggests that no quantity restrictions should apply to honey carried out of the country personally.

At a recent meeting of the Association, members expressed concern over the present system for controlling exports of honey.

The Honey Marketing Authority has been found by several members to be slow with export administration procedures, and it is understood that in some cases private packers have lost sales as a result.

Members are also concerned that considerable detail must be supplied by the private exporter to the Authority regarding his business, this information possibly being used by the Authority (his largest competitor) to his ultimate detriment.

The Association believes that the present system is not assisting the growth of the industry in general, and would prefer to see export controls administered by an independent (non trading) authority. In this we seek your assistance and advice. Ideally members would like to see the honey marketing regulations administered by your Department, but if this is not possible, then by some other independent body.

I trust this matter will receive your favourable consideration.

I acknowledge receipt of your letter of May 24 regarding exports of honey, and am sorry to have been so long in replying further to your letter.

I cannot add much to what I said in my original letter. From what I understand however, the Authority's domestic selling prices for its retail honey are nearly always higher than any of the private packers. In these circumstances it would seem that there is still room for private packers to increase their returns from the local market by raising their local selling prices to match those of the Authority's.

As beekeepers' incomes are dependent on the returns for honey, which in turn are dependent on how it is marketed, I feel that I must take into account the views of beekeepers on how their honey should be marketed, as expressed at elections for Honey Marketing Authority members.

On the question of export incentives you will by now be aware that extracted honey in retail packs is now eligible for the various export incentives.

I write in reference to your letter dated September 1 1978 in which you sought consultations on the final draft of the "Honeydew Regulations".

There are no plans to introduce "Honeydew Regulations". There are two items of legislation that your Association may be referring to :

 A proposed change to the Apiaries Act. The Ministry, with the support of the National Beekeepers' Association and the Honey Marketing Authority, proposes to recommend a change to Section 2 of the Apiaries Act 1969 regarding the definition of honey. It is proposed to adopt an internationally recognised definition

for honey. Honeydew would be defined as a category or type of honey. You may recall I discussed this matter with your Association at your meeting at Hastings on july 26 1978.

2. New Honey Export Regulations. For some years now it has been intended to up-date the 1950 Honey Export Regulations. I understand that your Association has been informed of progress from time to time. Recently it has been decided to reconsider these draft Regulations in the light of changing international requirements. Within the next few months I would be prepared to discuss with your Association the Ministry's proposed changes to the Honey Export Regulations. As the subject matter involves the physical and chemical properties of honey, labelling, and overseas honey regulations, I would recommend that your Association forms a small group of beekeepers who are interested in the export of honey and who are familiar with at least some of these aspects related to honey.

I believe that a meeting with representatives of your Association during the formative stages of preparing new Regulations is likely to result in a more effective contribution on the part of your Association than if I -- send you a copy of the final draft.

Could you advise me if you wish me to attend a meeting of representatives of your Association to discuss the proposed new Honey Export Regulations.

#### COLLECTIVE PRICING AGREEMENT APPLICATION

I refer to our discussions of 11 May 1978 concerning the above collective pricing agreement application.

The delay in coming back to you on this matter is regretted but during the intervening period we have held discussions and corresponded with the New Zealand Honey Marketing Authority on the subject of its price list. These discussions have led to the Authority notifying its individual resale price maintenance (IRPM) arrangement to the Examiner of Commercial Practices as required under section 28 of the Commerce Act 1975.

As you are probably aware, Section 28 of the Commerce Act recognises two types of IRPM - rigid IRPMs and flexible IRPMs. It is now illegal to operate a rigid individual resale price maintenance arrangement (where a reseller is <u>compelled</u> by the supplier to charge the nominated price) that has not been either approved by the Commerce Commission or is operating under the transitional provisions of section 30 (1) of the Act.

For flexible IRPMs arrangements (where the reseller can charge less than the nominated price without incurring any sanctions); provided the supplier has notified the Examiner of the arrangement and agrees to include the wording or a similar wording to that included in section 28 (4) (b), then the practice may continue. The New Zealand Honey Marketing Authority now fulfills the requirements of section 28 (4) in notifying the practice to the Examiner and in including the wording in section 28 (4) (b). You may have already noticed the appropriate wording on the Authority's recent price lists. Now that the Authority has notified its price guide, we propose to deal with your Associations application under section 27 (3) (b) of the Commerce Act. I have attached copies of section 27 and 28 of the Act for your information You will notice that, under section 27 (3) (b), where an association issues a price list, that has already been notified to the Examiner under section 28 (4) of the Act, to its members and the resellers who collectively take no part to fix or to enforce the resale prices, margins or markups contained in the list such an arrangement is excluded from the collective pricing provisions of section 27 (1) of the Act.

We wonder whether your Association would be prepared to pass a resolution at a general meeting of your members along the lines

"that only unaltered copies of the New Zealand Honey Marketing Authority's price lists will be distributed to members by your Association and that no sanctions be imposed on members who do not comply with the price list. No other price lists from any other source will be distributed unless the list first complies with Section 28 (4) of the Commerce Act 1975."

If such a resolution were passed, and we were provided with a copy we would be able to write a brief report to the Commerce Commission stating that your Association's arrangement now falls outside the collective pricing provisions of the Commerce Act and recommend to the Commission that it withdraw your Association's application from its public register. At this point I would draw to your attention the fact that should your Association wish to institute any kind of collective agreement and wish to alter the arrangement, after the Commerce Commission has deleted your application; then your Association would need to obtain approval from the Commission before the new practice were instituted.

We await your advice on this matter. Should you require any clarification on the above, please do not hesitate to contact me. Once again my humble apologies for the delay in replying to you.

It was resolved to write to the Ministry of Agriculture expressing concern at reports of proposals for the Pleasant Point plant, in view of the feasibility of the project and the adequacy of private packing plants.
