General Library Matters

Thank you for the report you prepared for the recent Executive meeting. It certainly helps a lot when a summary of activities and any requests for policy/approval are presented in such a clear manner. Its one of those things I want to extend to a lot of the other groups (branches, specialty groups, and so forth) - if they would jot down their ideas, concerns and plans to give to the Executive before a meeting, the meeting time can be so much more productive.

Keith had some photos he had taken of the library in its new location. Congratulations on a good job! It reminded me a lot of the time I first went to visit Chris Dawson in Timaru and actually got to see the library. I'm not sure how much most of our members recognise the real long term asset we have with such a collection of materials.

The Executive discussed the future of the library, and once again reiterated its confidence in you and any decisions you make about the library. We took on board your comments (I think from a previous report) that we should keep in mind looking for a replacement librarian. I just want you to know, John, that that decision will be yours - if there *ever* comes a time when you feel the library is taking too much of your time or effort, just let us know. But there will never be any suggestion of replacing you.

I would ask (I think I did say this in a previous letter) that you keep in mind the thought of letting Executive know of any potential future candidates for the job. Keith mentioned a few people you had discussed with him, and we even discussed the possibilities of approaching Frances Trewby. I'd be interested in your thoughts and comments. But for goodness sakes, John, *please* don't take this as any sort of indication that we are looking to replace you! That would not happen at all. I *personally* would like to hope you will continue to see the NBA Technical Library as something that you can continue with for many, many more years, providing you with interest and continuing involvement with the Executive and giving a very great return to the NBA.

After some discussion on the question of duplicated journal sets and foreign language materials, the Executive came to a sound decision. That is, you, Allen and Keith make the best decision for us! I believe that all the Executive really needs to do is give you the backing, the assurance that we will support whatever decisions the Library Committee makes in these issues. So talk it over between you all, and just let us know what you decide to do. And if there is anything the Executive could do to help, be sure to ask (letters, packaging, suggestions, etc).
